**RACE CONDITIONS:**

Starters to be named through the entry box by the usual time of closing. Total dollars earned will be used in determining the order of eligibility of the horses. The field will be limited to 12 starters. Horses not drawing a position in the starting gate will receive a refund of the entry fee or supplemental fee.

Money will be distributed as follows: 60% to winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth.

Weights – 118 pounds for Colts/Geldings, No Apprentice Allowance.

Owner or Nominator **MUST SIGN** the Nomination Form. No Refunds or Dropouts. No Refunds of Nomination Monies unless race is cancelled & Admin Fee will be kept. **RETURNED CHECKS WILL AUTOMATICALLY VOID NOMINATION**

*\*\*If fewer than six horses enter either the Lassie or Laddie, the two races (including all moneys) will be combined into one race. Fillies will receive a 3-pound weight allowance. Purse will be paid as follows: After \$1,000 is paid to horses that finish seventh or below, 50% to winner, 20% to second, 12% to third, 8% to fourth, 6% to fifth, 4% to sixth.\*\**

**COLORADO THOROUGHBRED BREEDERS-STAKE RACE CONDITIONS:**

**It is a condition of the Stakes that the owner making this nomination must be a member of the Colorado Thoroughbred Breeders Association. Such membership requirement must be complied with by time of nomination. If owner of the horse is different than nominator, they must also be a member of the CTBA at the time of race.**

**Owner/nominator assumes responsibility that the horse nominated is eligible for registration as a Colorado-Bred as required by the bylaws of the Colorado Thoroughbred Breeders Association.**

**If any time after nomination, it is determined that the horse nominated is not eligible for registration as a Colorado-Bred, there will be no refund of any nomination fees or any subsequent fees which have been paid by the date of such determination.**

**The signer on the reverse side represents that he/she and all persons for whom he/she is acting have read and are familiar with the Rules of Racing and the regulations of the Colorado Racing Commission, and the race meeting conditions, and agrees to be bound by and comply with the same, and with the racing officials and that all animals shall be subject to the same and to acts and decision of the racing officials. No stable reservation or entry into any race will be received except upon the conditions that all disputes, claims or objections arising out of the racing or with respect to the interpretations of any rule of conditions of races or otherwise shall be decided by the Colorado Racing Commission, the Stewards of the meeting or Arapahoe Park and such decisions upon all points shall be final. A decision to cancel any stake, or any other race, or change the date, reduce the added or guaranteed money, or reject any nominations prior to the running thereof, must be approved jointly by Arapahoe Park and the current horseman's representative organization without liability, except for the return of nomination and entry fees paid. In all Stakes, acceptance must be made through the entry box by the usual time of closing.**
